- The Government of the Republic of Uganda through the Ministry of Lands, Housing & Urban Development has received funds from The World Bank towards the cost of Uganda Support to Municipal Infrastructure Development Program Additional Financing (USMID-AF) to be used for the Financial Year 2022/2023 for the supply, delivery & installation of 30 weigh bridge accessories and tools for the 9 cities and Municipalities of Arua, Busia, Entebbe, Kabale, Kamuli, Kasese, Lira, Mubende and Tororo.
- 2. Bidding will be conducted in accordance with the Open domestic bidding method contained in the Public Procurement and Disposal of Public Assets Act, 2003 (as amended), and is open to all bidders.
- 3. All eligible bidders may obtain further information and inspect the bidding documents at the address given below at 7(a) from 9:00 a.m. to 4:00pm
- 4. Bidding documents in English may be purchased by interested bidders on submission of a written application to the address below at 7(a) upon payment of a non-refundable fee of UGX: 100,000 (Uganda Shillings: One Hundred Thousand only). The method of payment will be through obtaining a Bank Payment Advise Form from the cashier on 01<sup>st</sup> Floor and pay at the designated Bank with effect from 25<sup>th</sup> October, 2022. On presentation of proof of payment, bidding documents may then be collected from the Procurement and Disposal unit Room 17 with effect from 21<sup>st</sup> November, 2022
- 5. This procurement shall be open to both Local/Resident and Foreign Providers who are eligible to participate as per PPDA Guidelines
- 6. Bids must be delivered to the address below at 7(a) at 11:00am on 21<sup>st</sup> November, 2022. All bids must be accompanied with a bid security in form of a bank guarantee as indicated in the bid document. Late bids shall be rejected. Bids will be opened in the presence of the bidders' representatives, who choose to attend at the address in 7(b).
